Location

The land at Hayton is located outskirts of the village of Hayton. The town of Aspatria is approximately 3 miles away whilst the City of Carlisle is approximately 23 miles to the West and Cockermouth approximately 8 miles to the South.

Directions

Leave the A596 at the crossroads in the centre of Prospect (travelling from Carlisle, turn right) follow this road to the T junction in the village of Hayton and turn left on leaving the village of Hayton the land stands on the left marked with a for sale board.

Description of Land

The land comprises a single field enclosure extending to 18.05 acres (7.31ha) which is currently down to pasture. The land has the benefit of roadside access, is well fenced and is serviced by a mains water supply.

Tenure

The property is offered for sale Freehold with Vacant Possession being given on completion.

Basic Payment Scheme

The land is registered for Basic Payment purposes. The Entitlements are included in the sale, and will be transferred to the successful Buyer(s).

The cost of transferring these entitlements will be £250 + VAT, payable by the Buyer(s).

Environmental Scheme

Exchange of Contracts and Completion

The Buyer will be required to pay a deposit amounting to 10% of the purchase price on the fall of the auctioneer's hammer, at which point exchange of contracts will take place. (The deposit will be non-returnable in the event of the Buyer being unable to complete a sale for any reasons not attributable to the Seller or their Agents). It is anticipated that completion will take place on or before Wednesday 10th May 2017.

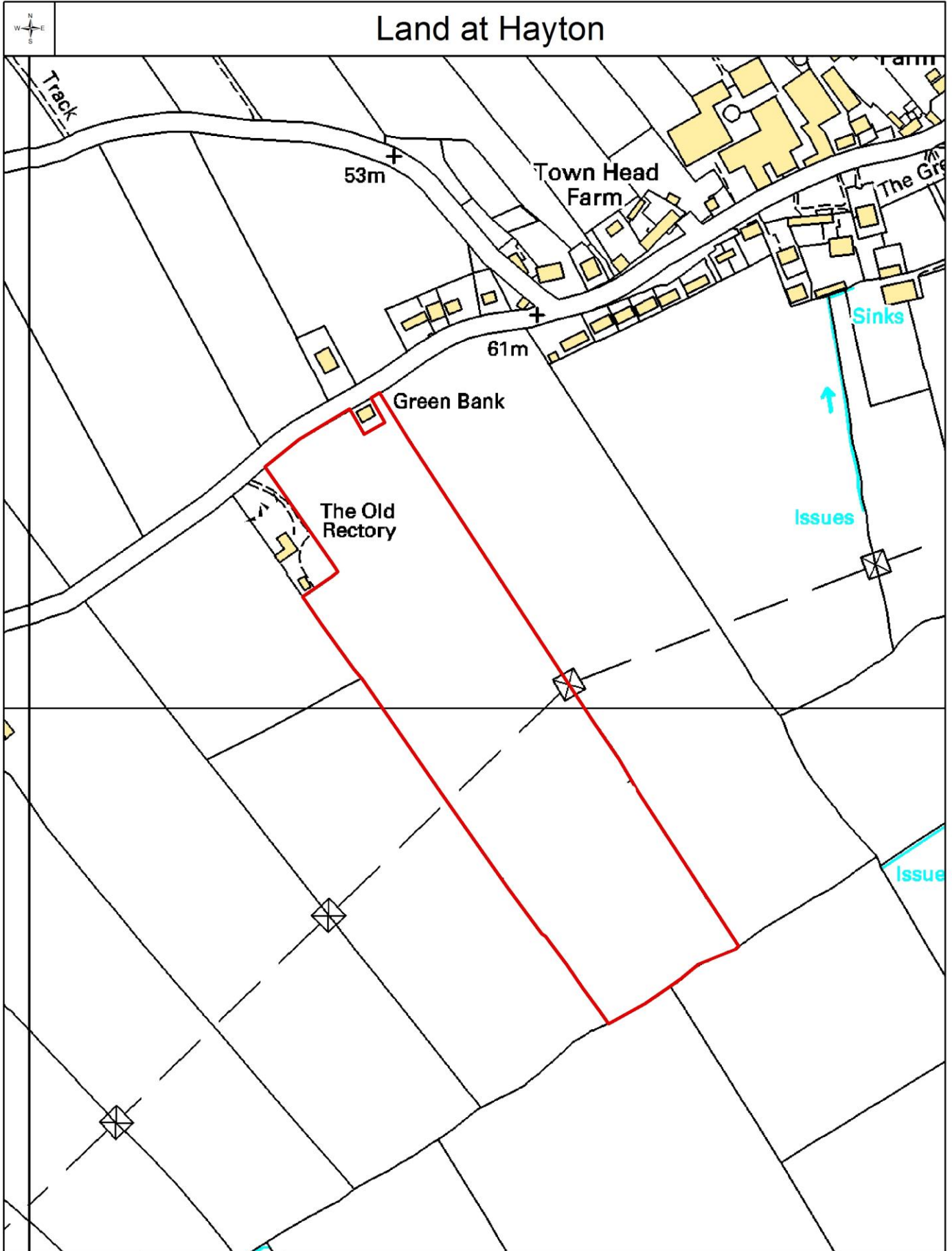
